One of the fundamental roles nations play is to embed individuals in a particular point in time and space. In other words, nations and nationalism, an organisational principle of social life, work to provide individuals with a sense of who they are and where they belong. While nations are not the only form of community to serve human kind in this manner, they are the most privileged due to their intricate relationship with the nation-state, the dominant form of political organisation. The ways in which nations and nationalism give shape to and maintain awareness and consciousness of time to members of nations and the importance of interpretation of the past in maintaining nations have been widely examined in the study of nations and nationalism under various headings including the use and abuse of history, the distinction between official and 'ethno-' history, nations without history and so on. Building on these works, the special issue aims to examine the specificity of genealogy as way of comprehending time in the formation and maintenance of nations and in articulating nationalism.
