The transport of livestock involves a complex series of operations, which includes handling, loading, journey, and unloading at the farm or at the abattoir. Stressors experienced during transport lead to adaptive responses at physiological and behavioural levels consequences for the health, productivity, and welfare of the animals transported. If the transport procedures are not carried out in such a way as to reduce unavoidable stress as much as possible, the consequences could be extremely serious, including mortality, loss of weight, morbidity, and impaired carcass and meat quality. Thus, a continuous up-to-date knowledge of the physiological and behavioural needs of the animals during transport is required in order to improve their welfare, health, and products.
