The clinical use of antibiotics, and therefore the effective treatment of bacterial infections, is under considerable threat due to the emergence of bacteria that are resistant to many classes of commonly used antibiotics. Therefore, the development of suitable alternatives to replace or at least to support systemic antibiotic therapy is much needed. Firstly, in terms of plant chemical ecology, it is logical that plants produce antibacterial metabolites as part of their chemical defence strategy to protect themselves against microbes in their environment. Secondly, there are countless examples of plants which are used topically and systemically to treat bacterial infections in the ethnobotanical setting. This Special Issue will be devoted to publish high-quality manuscripts evaluating the antibacterial properties of plant extracts and essential oils together with its chemical characterization. Moreover, studies regarding the anti-biofilm activity and/or the inhibition of quorum sensing mechanisms by plant extracts and essential oils are specially encouraged. The emergent approaches to control microbial growth incorporating natural bioactive compounds will be also of interest.
