Systematic reviews of past research on family carers in LMI countries, as well as papers that analyse policy implementation and conceptual frameworks to guide family-based interventions, will also be considered. The aim of this Special Issue is to provide examples of good practice that are viable for adoption in LMI countries while cautioning about pitfalls that are likely to be encountered.
