We define multiracial families broadly, including interracial couples, monoracial parents raising multiracial children, and families with transracial adoptees. We also welcome research that explores when family members, such as partners or multiracial children or adults, call attention to and/or resist white privilege in multiracial families. Additionally, we are interested in studies in which white privilege is restricted as a result of a white person being in an interracial relationship and/or multiracial family.
