It is my great pleasure and honor to announce this Special Issue on “Enhancing the Diagnosis of Acute Myocardial Infarction.” Over the last decade, intense collaboration between academic investigators and the diagnostic industry have allowed the integration of high sensitivity cardiac troponin (hs-cTn) assays into clinical practice worldwide. Although it is mandatory to use hs-cTnT/I algorithms, in conjunction with full clinical assessment and the 12-lead ECG, it is unknown how to best combine these diagnostic variables and how possible combinations would affect its performance characteristics.
