Orthognathic treatment is an interdisciplinary approach that implies a critical collaboration between orthodontists and surgeons from the very beginning. In recent years, it managed to correct many severe dentofacial problems that were once considered impossible to solve.

Even though the early form of treatment dates back more than 100 years ago, the greatest breakthroughs have happened in the last six decades: the sagittal split ramus osteotomy and the development of the LeFort I down fracture techniques. These two represent the beginning of the modern era of orthognathic surgery.
