### Message from the Guest Editors

Our special edition seeks clarity on the shifts from the perspective of the following vectors of inquiry: (1) The unprecedented series of political, economic and social traumas – associated with COVID-19, the rise in violent warfare, growing poverty and inequality, climate change – reconfigure perspectives on religion and belief in public life. (2) Simple readings of headline statistics of religious growth or decline fail to capture the nuanced and complex ways boundaries between the religious and secular are redrawn at a micro-public and locality level with implications for those margins at other scales. (3) As the world becomes more urban and global levels of religious affiliation broadly defined remain high, spatial and material relations between the religious and the urban become increasingly central. We look forward to receiving your contributions.
